GMO-PG selected as constituent of ESG investment indices of FTSE4Good Index Series, FTSE Blossom Japan Index and FTSE Blossom Japan Sector Relative Index

GMO-PG has been selected as a constituent of FTSE4Good Index Series, an investment index comprised of leading ESG corporations designed by FTSE Russel, as well as a constituent of FTSE Blossom Japan Index and the FTSE Blossom Japan Sector Relative Index.

As the leading company in the payment industry, GMO-PG is pursuing sustainability initiatives by promoting cashless payment that has a low environmental footprint as well as achieving zero GHG emissions from the major data centers that carry out payment processing on the annual gross merchandise value (GMV) of over \mathbb{1}3 trillion. In addition, GMO-PG is working to enhance ESG related disclosures including responses to climate change including GHG emission reductions, human talent development and compliance systems. GMO-PG believes that the selection into these indices reflects the evaluation of such initiatives. This is the first time to be selected into FTSE4Good Index Series and FTSE Blossom Japan Index, and the second consecutive year to be selected for the FTSE Blossom Japan Sector Relative Index.

Both FTSE Blossom Japan Index and FTSE Blossom Japan Sector Relative Index are ESG investment indices adopted by Government Pension Investment Fund (GPIF), one of the world's largest public pension funds, and together with the globally recognized FTSE4Good Index Series are all important criteria for making investment decisions.
