## Establish of "Recurrence Prevention Committee"

As stated in our previous report "Apology and Report for Leak of Personal Information Due to Unauthorized Access" announced on 10<sup>th</sup> March 2017, we found there were unauthorized external accesses to the payment site of our consignment merchants, Tokyo Metropolitan Government credit card payment site for metropolitan tax and credit card payment site for group life insurance rider of Japan Housing Finance Agency which leaded to information leakage.

We deeply apologize to our customers and all related parties for inconvenience and concerns caused by this incident.

The company paying serious attention to this situation and put all the company efforts to the related issues of the possibility of information leak due to unauthorized accesses and the company's system development and operation aspects. For the purpose to carry out the advanced measurement, the company would like to inform the establishment of "Recurrence Prevention Committee" which included external specialist advisors as per decision of extraordinary board meeting held on 14th March 2017.
